If An Officer Stops You

The legal term for this is a "Terry Stop"
(Supreme Court Case Terry vs Ohio)

(Disclaimer: While I strive to properly inform you. Knowing the laws of your State is essential, and can legally alter the following advice.)

Remain calm, do NOT raise your voice. We need to stay polite and calm so they can't make up an excuse to harass you.

Record everything on your phone!!

Stick to the script

1. "Why did you stop me?"

(A good cop will tell you, a bad one will not until ticketed or under arrest.)

2. "With respect, I'm not going to answer any questions."

(All cops will ask a series of questions, identify yourself if required by your State's Laws)

3. "May I have your name and the department you are with, please?"

(They are legally required to immediately answer this.)

4. "Am I being detained for a law enforcement investigation or am I under arrest?"

(They have to answer this. If they evade, ask again. If Detained or Arrested, proceed to the next line.)

5. "I respectfully invoke the 5th Amendment."

(At this point you are no longer required to speak at all. SAY NOTHING UNTIL SET FREE!)

6. "I want my lawyer."

(If arrested ONLY speak to YOUR lawyer)



Police Facts

1) Police are ranked #7 in a study of careers that attract psychopaths. Most Departments have rigorous testing to make sure these do not get the job. However, in underfunded departments, recruitment can be laxer and more dangerous.

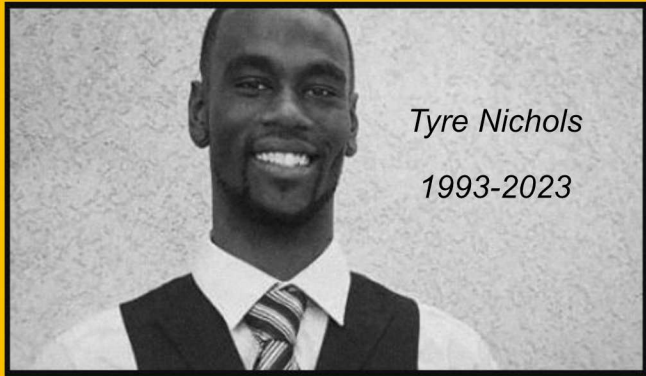

2) Police are allowed to lie to and trick you. Bad cops will even plant illegal things on you. It is essential to your freedom and property that you ALWAYS refuse ALL tests or searches that Cops ask to administer, sobriety, or searching of your car or person. Learn the 4th and 5th Amendments, make them get a warrant, and only speak to your lawyer!

3) Police are not required to protect you unless you are under arrest and in their custody. If you call out for aid, they have to try to assist. However, you and only you can see to your self-defense for sure.

4) After an encounter with the police you are entitled by law to get a copy of all body camera footage from the department that the Officer worked for. Reasons to do this are many, but include officer misconduct, or filing a report or complaint on the officer.

How to interact with the police is not taught very well in our society.

In the wake of the horrific death of Tyre Nichols in January 2023, I decided design this pamphlet: a quick reference guide for how to interact with the police in a reliable, safe, and respectful way.

There are an estimated 320 Million interactions with police every year in America, and according to the Bureau Of Justice Statistics: only a few thousand of those resulted in lethal force. Admittedly rare, yet one of those interactions is still the tragic murder Tyre Nichols at the hands Memphis Tennessee Police Department for 2023.

I want to educate you on your rights and allow you to move forward with a plan in confidence; to safely encounter the police and survive the day. Your family and friends should not have to watch what the Nichols Family did on television, and my heart breaks for them in all they have suffered.

Police can represent an extreme danger to your life, person, property, and freedom. Most are heroes, selflessly serving their communities with honor. However, some can be villains and destroy lives for personal gain and a promotion such as Zachary Wester.

All authority given to a government is eventually misused. I thus submit for your consideration the following.

We must naturally distrust any and all government officials. Question every decision they make to preserve and advance liberty and freedom, and never agree to give the Government power and authority you wouldn't want your worst enemy to have, because one day your worst enemy may get elected.

I urge the utmost caution and respect when interacting with the police, regardless of your feelings about them and what they may or may not deserve. It is highly likely that if they kill or harm you, they will get away with it and suffer no real consequences due to the nature of Qualified Immunity. If you maintain a calm and respectful demeanor it will be much more difficult for a corrupt officer to justify violence in court.

We ask that you make a record of the good police officers, the heroes, and champions and do kind things for them. They have a nigh impossible and stressful job. Brag on them, reward their honesty and good behavior publicly, even filing reports for good encounters. Turn the tide of bad cops in the news, and reward good behavior while simultaneously cleansing the world of the bad.

Similarly, if you encounter the bad ones, file complaints and sue the departments as the First Amendment Auditors do.
